

HOUSEHOLD SURVEY/ MICROPLAN EXERCISE:

For the 33 Batch I villages, household survey is under way with door to door visit and PRA exercises with the assistance of Village Council Members and GB's of the Villages.

GIS & MIS progress:

In order to set up a fully equipped GIS/MIS cell, competent companies such as ESRI, HEXAGON of International and National repute gave their presentations as per their request at Kohima. Companies of regional repute such as Tripura Info and NK Square also gave their presentations as per their request for setting up of MIS Cell. Officers from Working Plan Division were also deputed to NESAC, Meghalaya for short term period as an exposure visit to understand the set up of GIS Cell.

CAPACITY BUILDING

1. Sensitization programme for PMU, DMU, FMU and Batch I villages was held on 12° September 2018 at Forest Office Complex, Dimapur where the Minister of Environment, Forest and Climate Change, Shri.CM Chang attended as Special invitee. Aside from senior officers of the department, the Programme was attended by JICA India representative Mrs.Yuko Sinohara, NFMP Consultant Shri. AK Bhansal IFS (retd) and representatives from all the 33 Batch I villages. NFMP Operation Manual (OM) was released during the programme.

4. PIC and village visits by DMUs and FMUs

Prior-Informed Consent (PIC): Given the context of community ownership of land, especially in the village landscapes, the involvement and written endorsement of the Village Council (VC) shall be a prerequisite for inclusion of a village in the Project and for taking up forestry interventions. Community involvement in planning, execution and monitoring and their suitable capacity building/refinement shall be ensured through participatory processes and involvement of NGOs.

DAC FORMATION AND MEETINGS:




